

WARRANTY

10 YEARS



Ausdeck Patios and Roofing Pty Ltd ACN 100 815 889 ("Ausdeck") warrants to the Purchaser of Ausdeck Insulated Roofing Ribbed Profile ("Ausdeck Ribbed") and Ausdeck Insulated Roofing Corrugated Profile ("Ausdeck Corrugated") that Ausdeck Ribbed or Ausdeck Corrugated are free from defects caused by the manufacturing process of Ausdeck for a period of 10 years from the date of purchase ("the Warranty Period").

1. Subject to the conditions of this Warranty, if Ausdeck Ribbed or Ausdeck Corrugated have any defects caused by Ausdeck's manufacturing process within the Warranty Period Ausdeck will repair or replace Ausdeck Ribbed or Ausdeck Corrugated excluding labour and associated costs.
- 2.1 The Purchaser may during the Warranty Period notify Ausdeck in writing of any defect in Ausdeck Ribbed or Ausdeck Corrugated.
- 2.2 A signed copy of this Warranty must be presented with any claim.
- 2.3 Ausdeck shall inspect Ausdeck Ribbed or Ausdeck Corrugated or cause it to be inspected.
- 2.4 If the inspection by Ausdeck reveals no defect within this Warranty the direct and indirect costs and expenses associated with such inspection shall be borne by the Purchaser.
- 2.5 Any replacement or repair of Ausdeck Ribbed or Ausdeck Corrugated shall be at the discretion of Ausdeck and Ausdeck reserves the right to appoint its own repairers.
- 2.6 Ausdeck shall be under no liability to the Purchaser in respect of any loss or damage (including consequential loss or damage) or injury to persons which may be suffered or incurred or which may arise directly or indirectly in respect of goods supplied or in respect of a failure or omission on the part of Ausdeck to comply with its obligations under this Warranty.
3. Ausdeck will not be liable for any defects which are the result of:-
 - (a) Improper use or mismanagement by the Purchaser;
 - (b) Installation and use of Ausdeck Ribbed or Ausdeck Corrugated other than in accordance with the engineering manual;
 - (c) Use of Ausdeck Ribbed or Ausdeck Corrugated in a manner not reasonably contemplated by Ausdeck;
 - (d) Modification of Ausdeck Ribbed or Ausdeck Corrugated not authorised by Ausdeck;
 - (e) Use of Ausdeck Ribbed or Ausdeck Corrugated in a manner contrary to law;
 - (f) The subjection of Ausdeck Ribbed or Ausdeck Corrugated to unusual or unrecommended physical environment or electrical stress;
 - (g) Reinstallation or moving of Ausdeck Ribbed or Ausdeck Corrugated by a person other than an authorised installer;
 - (h) Use of Ausdeck Ribbed or Ausdeck Corrugated by a person other than the Purchaser;
 - (i) The Purchaser's failure to comply with any terms of the Warranty;
 - (j) Damage caused by:
 - (i) Handling, storage or erection;
 - (i) Structural pressure due to settlement or unusual loads;
 - (ii) Over painting;
 - (iii) Storm and tempest, floods, lightning strike or other acts of God;
 - (iv) Adhesion and marking due to the protective plastic film;
 - (v) Corrosion due to pollutants;
 - (vi) Chemicals and corrosive atmosphere;
 - (vii) Neglect, mistreatment or deliberate damage;
 - (viii) Contact with soils, ashes, fertilisers or other moisture retaining substances;
 - (ix) Areas in metallic direct or indirect contact with lead or copper or dissimilar metals, or subject to the run off from copper or lead flashings and pipes;
 - (x) Failure to remove debris and/or failure to provide free drainage of water including internal condensation from all surfaces of the product;
 - (xi) Deterioration caused by contact with green or wet timber or treated pine;
 - (xii) Exposure to temperatures above 75 degrees celsius.
4. The liability of Ausdeck for any breach of warranty implied by any legislation shall be limited to the replacement or repair of Ausdeck Ribbed or Ausdeck Corrugated or the supply of an equivalent, labour and associated costs excepted.
5. In accordance with the Warranty extended to Ausdeck by the manufacturer of the steel component of Ausdeck Ribbed or Ausdeck Corrugated, Ausdeck only extends to the Purchaser the benefit of the warranty and guarantees (if any) it receives from the manufacturer to the extent it is capable of doing so at law and provided that:
 - (a) Installation is greater than one kilometre from marine or severe industrial environments;
 - (b) The paint finish as supplied must not be scratched, abraded or damaged in any way, or coated with an incompatible material;
 - (c) Sheltered or areas unwashed by rain exposure must be washed down on a regular six month basis.
6. The provisions of this Warranty shall only apply to the following COLORBOND® steel colours manufactured by Bluescope Steel Limited:
